Property Taxes

The valuation is assessed to the owner of record as of April 1 of each year. Tax bills are generally mailed in August and are due by October 1.

If you bought your property after the April 1 deadline, the closing company should have explained that taxes were prorated at the closing. The current tax bill will NOT be in your name because you did not own the property as of April 1. It is a good idea to call or come to the town office and ask for a copy of the current tax bill.

Once you own the home for twelve consecutive months, you are eligible for the Homestead Exemption. Applications are available at the town office and on our website www.townofindustry.com.

Dogs

Dog licenses are annual and are required by state law for all dogs over 6 months old. Licenses cover the calendar year, and the town begins licensing on October 15 for the coming year. A copy of the rabies certificate must be provided.

- Late fee: \$25.00 beginning February 1st

- Glass Containers
- Colored HDPE #2 Plastics – Bottles
- Natural HDPE #2 Plastics – Bottles
- Steel Cans (tin cans)
- Aluminum
- Compost

The Town of Industry does not provide trash pickup services. You may contract with a local hauler to dispose of your household trash.

Long Island Waste Services also provides trash drop-off at the Farmington Recycling Facility for a fee per bag.

Voting

All voting takes place at the Industry Town Hall, 1033 Industry Road

Are you registered to vote? You can register at any time during office hours, online, or on Election Day. To register, you need to provide us with a valid ID and proof of residency. If your

driver's license does not show a valid Industry address, we will accept a current utility bill, bank statement, pay stub, current motor vehicle registration, or a rent receipt/lease agreement for proof of residency.

When should you update your voter registration?

- Voter registrations are not automatically transferred. Therefore, you must remember to register in your new town of residence.
- Marriage/Change of Name
- Change of Address (even if it is within Industry)
- Change Party Enrollment

Motor Vehicles

If you have moved to Industry from another state, you will need the following to register your vehicle;

- title or lien-holder information
- most recent registration from the state you moved from
- proof of insurance

If you moved here from another municipality in Maine, we need the most recent registration and proof of insurance.

* Titles are required for all vehicles 25 years old and newer. *

Rapid Renewal:

After your vehicle has been registered in Industry, you have the option of using the Rapid Renewal service for re-registrations. You can also sign up for reminders to be emailed a month before your registration is due.

Building Permits and Codes

Building permits are required for any structure over 200 square feet. Permits are available at the town office and on our website. Our Code Enforcement Officer / Plumbing Inspector does not hold office hours and works on an as-needed basis. Please feel free to contact Jon with any questions or schedule a meeting. The Planning Board meets once a month at the Town Hall on the third Thursday at 6:00 pm to review and approve any building permits.

Physical Addresses:

If you are building a new residence and need a physical address assigned, please contact our Addressing Officer.

General Assistance

The General Assistance Program is intended to assist people who are in need and have nowhere else to turn. It assists with basic necessities such as rent, food, medication, heat, utilities, and personal and household supplies.

Applications are available at the Town Office and on our website. All information concerning general assistance is confidential.

Burn Permits

A burn permit is required by state law for individuals seeking to burn brush piles, wood debris, and agricultural burns. A permit is also needed for recreational campfires larger than 3 feet high and more than 3 feet in diameter.

Notary Public

Our Town Clerk is also a Notary Public. The Town offers this service at no fee. Please bring a photo ID.

Marriage License/ Wedding Service

If you are getting married, you will need to file your intentions at Town Office and apply for a marriage license. If either party has been married previously, we require documentation showing how that marriage ended. Divorce decrees must have the raised seal from the Court Clerk. A marriage license costs \$40.

We recommend you either download or pick up a copy of the Intentions of Marriage Form from the town office to complete in advance, but do not sign it as it needs to be notarized. The form must be legible and completed with black ink. Every box must be completed; if unknown, enter UNKNOWN.

The staff at the Industry Town Office does not provide wedding services.

Winter Sand

Residents of Industry may come to the Town Hall/Public Works to get sand for slippery driveways and walkways for free! The sand is located in a small shed to the right of the Town Hall. Please only take 1 – 2 pails per day. Do not get sand from the large sand building.

Sand is for private residential use only

Public Library

The Farmington Public Library is located at 117 Academy Street in Farmington, where all Industry residents are eligible to use.
